## Meeting of ISO TC190, Brno, Czech Republic - September 2018

As usual the number of UK "experts" expected to attend is at present only three. Further volunteers to attend would be very welcome.

#### **Revision of BS 10175**

The response to the request for views regarding the need or otherwise for a formal revision of BS1075 +A2: 2017 has been disappointingly limited including from members of the BSI committee (EH4). BSI EH4 decided in June 2018 to delay any action given the apparent indifference by users of the standard. In the meantime, anyone that has views about the need for revision should continue to send them to BSI (jessy.mathew@bsigroup.com).

#### Sampling soils for VOCs

The drafting panel (EH4/06) for this new standard (BS10176) met for the first time on 3 May. The aim is to circulate the Draft for Public comment in February 2019.

### BS ISO 1400 Series of Standards - Soil quality - Sampling

There has been some progress regarding the remaining five members of the BS ISO 18400 series of standards (-104, -202, -203, -205 and -206).

ISO 18400-104 (sampling strategies): ISO is preparing the FDIS

ISO 18400-202 (preliminary investigations): FDIS to be circulated for comment in early July.

ISO 18400-203 (potentially contaminated sites): FDIS to be circulated for comment in early July.

ISO 18400-205 (natural and near natural etc. sites): FDIS to be circulated for comment in early July.

**ISO 18400-206 (sampling for biological testing):** Proceeding to publication.

#### EN ISO 25177 Field soil description - Revision

This standard had been around for a long time. However, the DIS which was recently circulated was not of acceptable quality in terms of English and conformity with ISO rules. BSI & Germany voted against the draft standard proceeding to FDIS. The UK has asked for a second DIS to be produced. Following a meeting in Paris at the end of May, a substantially revised version is being prepared for discussion in September 2018. A decision whether to produce a second DIS will be made in September.

#### ISO 15800 Soil characterisation in relation to human exposure - Revision.

Not previously a BS. The UK has asked for a second DIS to be produced. Comments on the DIS will be discussed in September 2018.
